

Player Agreement 2024 Season

By registering to play for the Kapiti Hockey Club for the 2024 season, I understand and agree to the following conditions:

FEES:

- I will pay a deposit if \$100 by Wednesday 17 April 2024. The deposit is non-refundable
- I will pay the balance of the fees no later than Wednesday 22 May 2024, unless an arrangement has been agreed with the Club to pay in instalments.
- If I do not pay my fees, I know that I may not be allowed to play for the Club, and I may be reported to WHA as unfinancial which would prevent me from playing for any other club until the fees are paid.
- I know the Club will engage a debt recovery agency for any money I owe the club and know that I will be responsible for any additional costs required to recovery this debt.
- I know I can contact the Club, in confidence, if I am having difficulty paying my fees

PLAYING KIT, INCLUDING GOALIE GEAR:

- I will be given a playing uniform to use for the 2024 season, and I know I must return it at the end of the season.
- The playing uniform will include a shirt and shorts/ skorts/ skirts. A goalie kit will include a full keepers kit.
- I will look after the kit and will return it to the Club in good clean condition at the end of the season.
- If I have not returned the playing kit within two weeks of my last game, I know I will have to pay a replacement cost of \$120 for a playing kit, and \$2,225 for a keeper kit.
- If I do not return my playing kit and do not pay the replacement cost, I will be reported as unfinancial with WHA.
- I know the Club will engage a debt recovery agency for any money I owe the club and know that I will be responsible for any additional costs required to recovery this debt.

PLAYER CONDUCT

- Kapiti Hockey is governed by Wellington Hockey, who are bound by the rules decided by the International Hockey Federation (FIH). These rules place emphasis on safety and wellbeing of participants, ensuring all involved act with consideration of others. I acknowledge and agree to participate accordingly.
- Additionally, I will inform my team organiser if I cannot make training sessions and games.
- I will endeavour to support club fundraising and social initiatives.

HEALTH & SAFETY

• I agree to comply with any health & safety rules and instructions issues by WHA, HNZ and/or the Club, including contact tracing measures.

PHOTOS

• From time to time the Club may arrange for photographs to be taken of the teams, either as groups, or while playing. I know that these photos will be used to celebrate our club and our sport in online channels such as Facebook, Instagram, our website, and for promotional purposes.

SHARING YOUR EMAIL WITH SPONSORS

• From time to time the Club receives support from sponsors which helps pay for my playing kit, playing equipment and some of my fees. I know the Club may share my email address as part of a sponsorship arrangement. The Club will notify club members if they enter in such an arrangement, and members can opt out.

COMMUNICATING WITH YOU

- I will provide the Club with an email address as part of the registration process, and I know that this will be the primary channel of communication for any notices the Club may send me.
- I know that my email will be used by the Club to send me newsletters and other club information.
